## Contracts

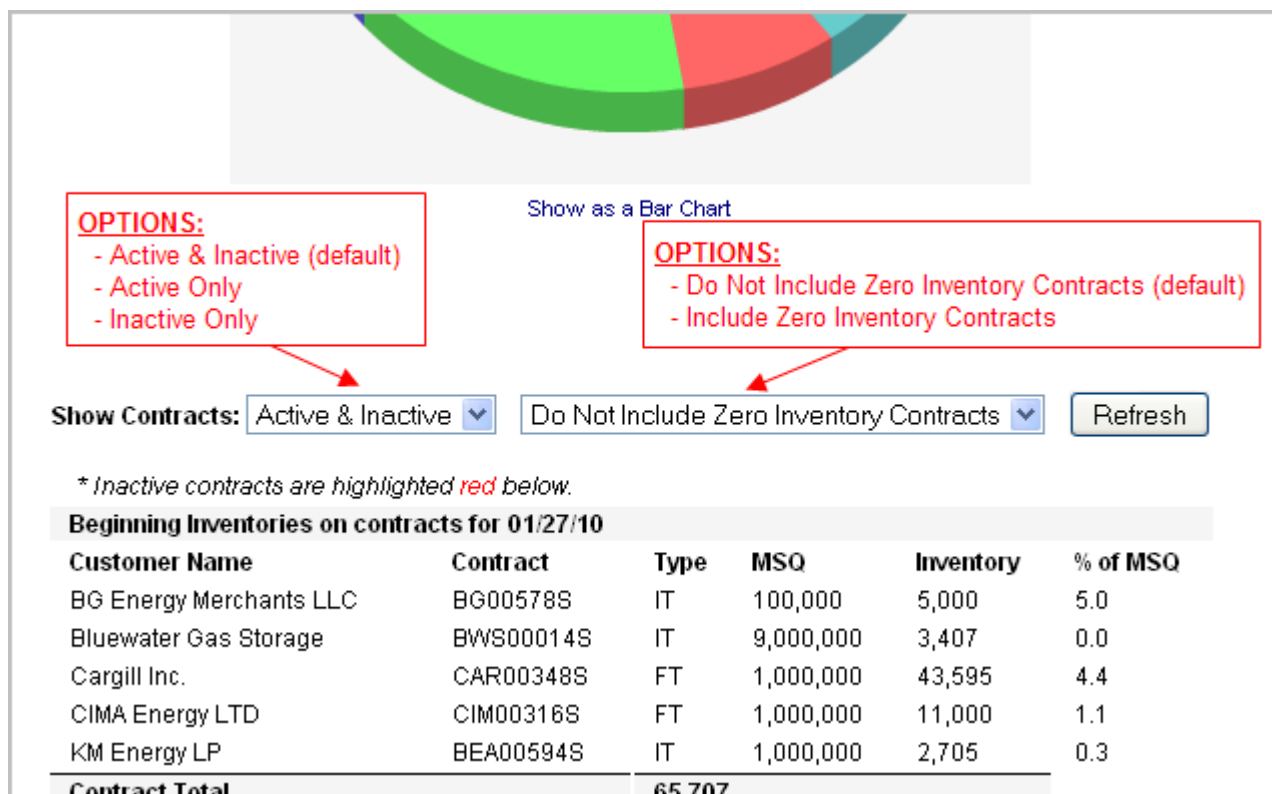
- On Hub contracts, the **Wheel To Hub** transaction type now has **fuel**.

## Nominations

- New Global Setting: When a Customer **updates the Nominated Quantity INTRADAY**, system will **automatically update the Scheduled Quantity**.
  - \* By default, your NGI system will NOT automatically update Scheduled Quantities*
  - \* To enable this setting, please contact Kyle Murphy at [kyle@latitudetech.net](mailto:kyle@latitudetech.net)*
- When performing a **Dome Swap**, you will now be notified if it results in negative inventory.
- Smarter MDQ checking** when editing and deleting nominations
  - If you change a Point when editing a nomination, NGI will now perform a MDQ check on both points.
  - When deleting a nomination, a MDQ check will be performed to ensure that no violation has occurred.

## Facility Inventory

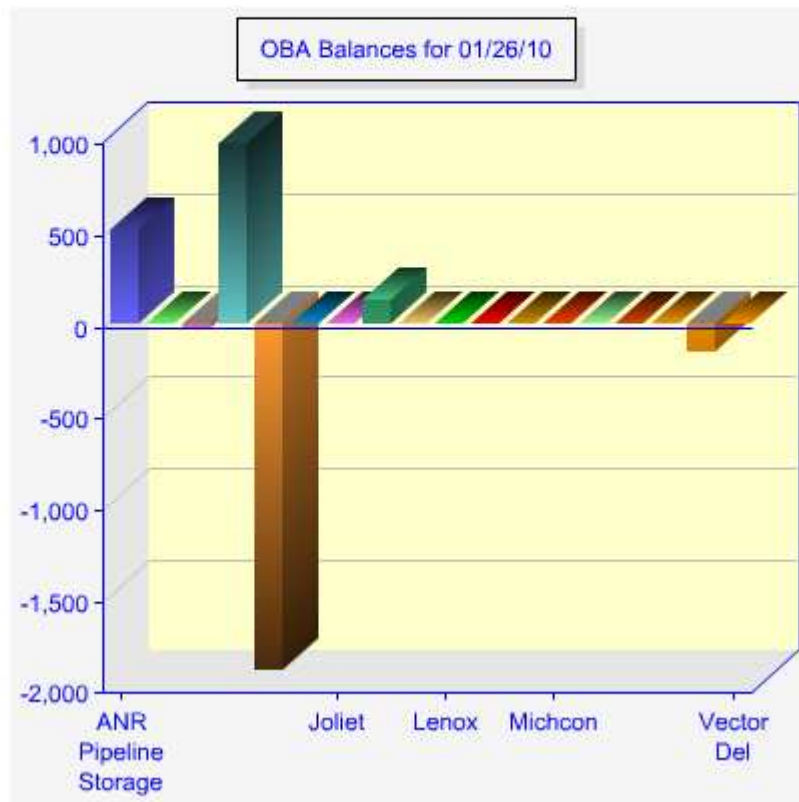
- New **filters** allow you to customize your contract view
